Toulouse Oliver Named Elections Government Sector Coordinating Council Member at Inaugural Meeting

SANTA FE – New Mexico Secretary of State Maggie Toulouse Oliver was officially named a member of the Elections Government Sector Coordinating Council (GCC) at its inaugural meeting in Atlanta, Georgia on Saturday. The 27-member council is made up of state and local election officials and representatives from the United States Department of Homeland Security (DHS), the Election Assistance Commission (EAC), the National Association of Secretaries of State (NASS), the National Association of State Election Directors (NASED), and the International Association of Government Officials (iGO).

"Keeping New Mexico's elections secure is one of my top priorities, and I am proud to represent our voters as one of the founding members of the GCC," said Secretary of State Toulouse Oliver. "Given what we know about the bad actors trying to undermine American democracy, state and federal agencies must work together to guard against threats to even a single vote."

Saturday's meeting – during which members adopted the council's first charter – is a major development following a move by DHS in January to designate U.S. election systems as critical infrastructure. GCC members are now charged with improving communication between states and the federal government on issues like cyber threats and improving the overall security of local voting systems.
